INSTRUCTIONS FOR MOTION TO/FOR

Before a Judge (or in certain instances, a General Master/Hearing Officer) can hear your case, you must first put in writing what you are asking the Court to do and why. Usually this is done in the form of a *Motion*. Some examples of Motions you might file are:

Motion to Compel Discovery
Motion to Continue
Motion to Clarify
Motion for Contempt*

Once you have filled out the Motion, (see attached example) you must file the original with the Clerk of Court. It is your responsibility to be sure the other party to your case is properly served with a copy of the motion. For help with having the other party served by the sheriff, or by a private process server contact the Clerk of Circuit Court – Civil Section at: 1-800-368-2411 Ext. 4292.

Once the other party has been "served", you must file with the Clerk of Court, a request/motion for hearing and two (2) stamped envelopes. After filing your request/motion for hearing you will be notified by mail of a court date.

*If this Motion is filed after a Final Judgment has been entered:

- (1) the Motion should be set for Hearing before a General Magistrate.
- (2) the Motion should **not** be used to modify any provisions of a Final Judgment. Instead, a Supplemental Petition must be filed.
